IN CONSIDERATION of you having agreed or agreeing at the request of the Guarantor to provide services and/or financial accommodation to the Debtor, the Guarantor agrees with you as follows:-

1. The Guarantor shall be answerable and responsible to you for the due and punctual payment by the Debtor for all such services as you may from time to time supply to the Debtor and for all sums of money which may be owing by the Debtor to you from time to time.
2. This agreement shall be a continuing guarantee to you for the due and punctual payment for all services and for all debts whatsoever and whenever contracted by the Debtor with you in respect of services to be supplied by you.
3. The Guarantor indemnifies you and keeps you indemnified against any loss that you incur as a consequence of any failure of the Debtor to make due and punctual payment of any monies due to you.
4. You are at liberty at any time and without notice to the Guarantor and without discharging or impairing the liability hereunder of the Guarantor:-
 - 4.1 to refuse to provide further service to the Debtor; or
 - 4.2 to refuse to provide further financial accommodation to the Debtor; or
 - 4.3 to grant time or other indulgence to the Debtor.
5. You may enforce this agreement against the Guarantor without first being required to pursue any remedy against the Debtor.
6. The liability of the Guarantor will not be discharged or impaired by:-
 - 6.1 any negligence or laches on your part in enforcing your rights against the Debtor or Guarantor; or
 - 6.2 judgement being entered by you against the Debtor; or
 - 6.3 any payment made by the Debtor to you which is void or avoided by any statutory provisions; or
 - 6.4 any change in ownership of the business of the Debtor; or
 - 6.5 any release waiver or variation of this agreement.
7. Where the Guarantor consists of two (2) or more persons (natural and/or corporate) the obligations of the Guarantor under this agreement shall bind them jointly and each of them severally and the liability of each Guarantor will not be discharged or impaired by:-
 - 7.1 the death, mental incapacity, bankruptcy, or liquidation of the other; or
 - 7.2 any Guarantor not signing this agreement; or
 - 7.3 this agreement ceasing to be binding as a continuing guarantee on any Guarantor; or
 - 7.4 the release by you of any Guarantor from this agreement.

8. If any provision of this agreement is or is held to be valid, void or enforceable for any cause whatsoever the same shall not in any way prejudice or affect the validity or enforceability of the remaining provisions of this agreement.
9. The Guarantor shall reimburse you for the expenses incurred by you in connection with the enforcement of or the preservation of any rights under this agreement including legal costs and expenses on a full indemnity basis.
10. Any monies payable by the Guarantor to you pursuant to this agreement shall be paid to you at such a place in Queensland as you may from time to time direct.
11. Any proceeding arising from this agreement shall be instituted and determined before a Court of competent jurisdiction in Queensland selected by you and the Guarantor shall submit to the jurisdiction of such Court and this agreement shall be construed according to the laws of the State of Queensland.
12. A certificate signed by you or on your behalf as to any sum payable to you pursuant to this agreement as at the date set out in such certificate with or without particulars thereof shall for all purposes be accepted as prima facie evidence of the amount due to you and the Guarantor will not object to the admissibility of such certificate in any legal proceeding.
